Privacy Policy

1. INTRODUCTION

This privacy policy (the "Privacy Policy") explains the information Fintech Data LLC d/b/a CRED iQ and our related service providers, vendors and other parties referenced below (collectively "CRED iQ", "we", "our" or "us") collects, how we use and share it and your rights in connection your access to and use of www.crediq.com, including any content, functionality and any related services (collectively, the "Service"). We also use the services of Stripe.com for data collection and processing, and therefore refer you to its privacy policy here for you review and acceptance. Please also read our Website Terms of Use which sets out the terms governing the Service. If you are customer, you are also governed by the Master Subscriber Agreement or a separate binding agreement.

By accessing or using our Service, you signify that you have read, understood and agree to our collection, storage, use and disclosure of your personal information as described in this Privacy Policy. If you do not want to agree to the Website Terms of Use or the Privacy Policy, you must not access or use the Service.

2. CHANGES TO OUR PRIVACY POLICY

CRED iQ may modify or update this Privacy Policy from time to time to reflect the changes in our business and practices, and so you should review this page periodically. When we change the policy in a material manner, we will let you know by posting an announcement, sending you an email, or updating the Privacy Policy on our website (including by updating the 'last modified' date at the bottom of this page). Use of information we collect now is subject to the Privacy Policy in effect at the time such information is used. You are encouraged to review the Privacy Policy from time to time in the event changes have been made. You are bound by any changes to the Privacy Policy when you use the Service after such changes have been first posted.

3. INFORMATION WE COLLECT

A. Information Collection from Users

When you engage with the Service (i.e., visit the website, enroll for a free trial or purchase a subscription), we collect information (a) from you and (b) from automated technologies.

<u>Information You Provide</u>: The types of information you may provide, depending on whether you enter into a binding agreement with CRED iQ for access and use of the Service pursuant to a free trial or a full registered account ("CRED iQ User"), may include:

- Personal information, including information necessary to register your account.
 - o Your name, postal address, phone number, and email address.
 - Account credentials, such as username and password.
 - Organizational information necessary to register an account, such as company name and job title;
 - Payment information, such as a credit or debit card or other billing information.

- <u>Feedback</u>, such as comments, survey response, inquiries, feedback and other information, including questions submitted to our support team.
- <u>Information of third parties</u>, such as information of others you may provide to us, such as the email address of someone you invite to collaborate or a third party referral.

<u>Information Collected from Your Use of the Service</u>: We collect information automatically when you browse the CRED iQ websites or use the Service, including:

- <u>Usage information</u>, including monitoring the activity of the Service and features you use, content you access, and any actions taken in connection with your information and content in the Service.
- <u>Log Information</u>, such as log file information from your computer or mobile device each time you access the Service, Internet Protocol ("IP") address, browser type, referring/exit pages and URLs, number of clicks and how you interact with links on the Service, domain names, landing pages, pages viewed, and other such information.
- <u>Device Information</u>, such as information about the device (e.g., computer, mobile device, etc.) used to access the Service, your IP address, the time and date, and other statistics.
- Google Account Authentication. Google's authentication method called OAuth 2.0 is an open standard authorization protocol that allows third parties to obtain your user data without access to your passwords. By enabling OAuth 2.0, you permit third party applications and services, such as Google, to provide your third party account information, such as user ID, name, location, and IP address to CRED iQ, solely for identification purposes during login. If stored, we will store such account information in a database hosted in Amazon Web Services. CRED iQ will not need to know or store your passwords for third party applications and services. OAuth 2.0 allows a CRED iQ User to revoke CRED iQ's access at any time in Google settings. If a CRED iQ User revokes CRED iQ's access, our Service does not have access to any of the user data anymore. If OAuth 2.0 is not supported, we will require your account username and password in order to provide the Service.

<u>Information from Cookies and Similar Technologies</u>: We use certain technologies to automatically collect information about how you interact with the Service, which may include:

- <u>Cookies</u>, provided by CRED iQ and our service providers, are a small text file containing a string
 of alphanumeric characters and uniquely identify your device. For more information regarding
 cookies, see "Cookies and Similar Technologies" in Section 6 below.
- <u>Web beacons</u>, also known as clear gifs, pixels, images and scripts, may be enabled by CRED iQ and our service providers.

Other: You also may provide information to be published or displayed (hereinafter, "posted") on public areas of our website, or transmitted to other users of the website or third parties (collectively, "User Contributions"). Your User Contributions are posted on and transmitted to others at your own risk. Although you may set certain privacy settings for such information by logging into your account profile, please be aware that no security measures are perfect or impenetrable. Additionally, we cannot control the actions of other users of the website with whom you may choose to share your User Contributions. Therefore, we cannot and do not guarantee that your User Contributions will not be viewed by unauthorized persons.

B. Information Collection for the CRED iQ Platform

<u>Information from Third Parties</u>: We may obtain certain personal information about you from third parties, which may include information from publicly-available and private data suppliers, from which we procure to validate or supplement our information in order to provide the Service, such as:

- <u>Personal identifiers</u>, including your name, postal address, phone number, and email address;
- Commercial information, including commercial real estate sales, tax and debt information; and
- Professional or employment-related information, including job title and your affiliated organizations.

4. HOW WE USE INFORMATION

CRED iQ uses information collected for the purpose of providing the Service. Depending on your level of interaction with us and the Service, we may use your information to:

- Provide, operate, maintain, and improve the Service;
- Enable you to access and use the Service, including downloading and collaborating with CRED iQ content;
- Send you technical notices, updates, security alerts, support and administrative messages;
- Provide and deliver the services and features you request, process and complete transactions and send you related information, including purchase confirmations and invoices;
- Respond to your comments, questions, and requests, and provide customer service and support;
- Communicate with you about services, features, surveys, newsletters, offers, promotions, contests and events, and provide other news or information about CRED iQ and our business partners;
- Process and deliver contest or rewards;
- Monitor and analyze trends, usage, and activities in connection with the Service and for sales, marketing or advertising purposes;
- Investigate and prevent fraudulent transactions, unauthorized access to the Service, and other illegal activities;
- Personalize and improve the Service, and provide content and features that match your interests and preferences or otherwise customize your experience on the Service;
- Send you push notifications from time-to-time in order to update you about events or activities related to the Service:
- Link or combine with other information we receive from third parties to help understand your needs and provide you with better service;
- Enable you to collaborate on and share content with users you designate; and
- Comply with our legal obligations, resolve disputes, and enforce our agreements.

B. General Disclosures of Information

We may also share your information as described below:

- <u>CRED iQ Affiliates</u>. Other companies owned by or under common ownership as CRED iQ, which
 also includes our subsidiaries (i.e., any organization we own or control) or our ultimate holding
 company (i.e., any organization that owns or controls us) and any subsidiaries it owns may receive
 your information.
- <u>Service Providers</u>. We share information with third party vendors, consultants and other service providers that perform services on our behalf, in order to carry out their work for us, which may

include identifying and serving targeted advertisements, content or service fulfillment, billing and payments processing, or providing analytics services;

- Business Transfer. We may share your information in the event of a business transfer such as a
 merger, sale of company assets or shares, purchase of another entity's assets or shares,
 reorganization, financing, change of control or acquisition of all or a portion of our business by
 another company or third party or in the event of bankruptcy or related or similar proceedings;
- Organizational Communication. We may share your information with members of your organization such as your employer if you are accessing the Service in your capacity as an employee, independent contractor, or agent of one of our enterprise customers or otherwise using an email address provided by your employer who is one of our enterprise customers; and
- Compliance with Law. - <u>Aggregated or Anonymized Data</u>. We may also share information with others in an aggregated and anonymous form that does not reasonably identify you directly as an individual.

6. COOKIES AND SIMILAR TECHNOLOGIES

We send cookies to your computer through your browser to enable our systems to recognize your browser and tell us how and when pages on our site are visited and by how many people. Most browsers have an option for disabling the cookie feature, which will prevent your browser from accepting cookies, as well as (depending on your browser software) allow you to decide on acceptance of cookies in a variety of ways.

Ads appearing on the Services may be delivered to users by our advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. As a result, United States (or other) federal and state governments, courts, or law enforcement or regulatory agencies may be

able to obtain disclosure of your information through laws applicable in the United States (or other jurisdiction).
